

## Terms of Participation in the 3<sup>rd</sup> Edge Computing Forum (ECF) 2019

### 1. Contracting Partner

The Fraunhofer Institute for Open Communication Systems (Fraunhofer FOKUS), a constituent entity of the Fraunhofer-Gesellschaft zur Förderung der angewandten Forschung e.V., München (referred to as “the organizer”), is the organizer of the 3<sup>rd</sup> Edge Computing Forum 2019. Kontrapunkt Agentur für Kommunikation GmbH is in charge of registration, invoicing and payment handling on behalf of the organizer.

### 2. Your Consent

### 4. Cancellation Policy

Cancellations will only be accepted in writing by e-mail.

All refund and cancellation requests must be sent to [info@ec-forum.org](mailto:info@ec-forum.org). For cancellations received before October 10, 2019, we will charge a cancellation fee of 40.00 € per ticket, after that time a fee of 80.00 € per ticket will apply. There will be no refunds after October 17, 2019. Alternatively, you may nominate someone else to attend free of charge.

Refunds will be processed after the events.

There will be no reimbursement if the participant fails to attend or for items not claimed by the participant such as sessions, meals, or complementary events.

### 5. Agreement for Visual and Sound Recordings

By participating you agree that for the purposes of presenting the event in internal Fraunhofer media and for public reporting on the event, you irrevocably relinquish to the Fraunhofer-Gesellschaft all exclusive, assignable, spatially unlimited and temporarily unlimited rights for any use or publication of the material, either unchanged or edited, by yourself or by third parties. This shall apply irrespective of the transmission, transfer, or storage of technologies used (notably digital image processing). ## **6. Privacy**

## **7. Liability**

The organizer is not liable for the immediacy, correctness, or completeness of the event proceedings or the holding of the event. The participant accepts that she/he has no claim for damages or any loss against the organizer (except in the case of willful misconduct) if the event is cancelled due to force majeure or for good reason (including, but not limited to, illness of one or more speakers, a low number of participants, or financial reasons). The organizer reserves the right to change the program of the event and/or the speakers at the event at any time.

## **8. Place of Jurisdiction**

For this agreement, German law applies. Place of performance and jurisdiction is Berlin, Germany.
